- b. Mother Son Nerf War- Sold 71 tickets so far. Will be hosted in gym and cafeteria. \$180 spent on nerf bullets. Will host for k-5<sup>th</sup> grade students/mothers only. Some parents have requested an event for 6-12<sup>th</sup> graders. Discussed adding an additional event. Jamie will consider options. Jamie is seeking large boxes to serve as blinds/baricades in the gym for the event.
- c. Update on programs
  - i. Good turnout and support for ukulele classes. Babysitting classes are a hit.
  - ii. Summer Concert Series: Discussed hosting the “Growlers” and “Sea Cruisers” (performing twice). Consider getting sponsors to cover the costs of the summer concert series. Suggestion to finding sponsorships prior to booking bands.
- d. Freezing for a reason 2020- Reviewed current sponsors. 10 people are signed up for the event. Randy presented some pitches that he presented to local fast food restaurants to gain some additional participation. Expenses approaching around \$750. Sponsorships cover the cost.
